



# Coaching and Consulting with Teams: Applying the Cape Cod Model in Organizations

This program provides advanced practice in the organizational applications of the Cape Cod Model®, a competence-based approach to facilitating greater effectiveness and change. Practitioners will sharpen their ability to coach teams and consult with groups. Class size is limited to assure concentrated practice working with real clients and an opportunity to receive individual feedback.

This five-day intensive program provides three days of practice, two of which are working with visiting client teams. Time is also devoted to case consultation in which participants work with their own cases in facilitated peer supervision groups, providing an opportunity to resolve troublesome case issues.

Participants are observed and coached as they work with a client, receiving feedback from master facilitators as well as from the client group themselves. Emphasis is focused on seeing group competence and development opportunities and learning to provide bold and direct feedback along with techniques to assess effectiveness of interventions.

Organizations sending internal consultants or coaches will be given an opportunity to send an intact team for a free one-day consultation as one of the client teams in the program.

## Benefits

Participants will:

- Learn to assess and intervene in hierarchical and non-hierarchical teams
- Gain experience coaching with and consulting to teams of different types of organizations
- Receive personalized feedback from organizational clients, peers and faculty
- Have an opportunity for extensive practice
- Develop insight and new perspectives regarding their current work situations

## Participants

This program is designed for experienced practitioners of the Cape Cod Model© who work as external or internal coaches or consultants and have taken at least one of the following: Cape Cod Training Program, Enhancing your Skills as an Intervener, Introduction to the Cape Cod Model, or Applying the Cape Cod Model to Coaching.

\*Experienced practitioners and leaders who have not completed any of the prerequisite programs are required to participate in a one-day pre-program workshop which teaches the Cape Cod Model®; Fee: \$425 US. Combined fee for both the pre-program workshop and Coaching and Consulting with Teams: \$2,720 US.
